Inspector Findings

Cold holding make unit across from grill non-functional. Per interview with operator, they do not need unit and part to fix was expensive. Discussed requirement to maintain (fix) their refrigerator unit. Operator indicated he wishes remove unit from facility and replace with a prep table.
