Door gasket broken on middle door of 3 door refrigerator in 3 bay sink room. Food items in refrigerator unit temped at 44dF. Still under time table of correction (TTOC) of 4/27/17.

ITEM # 15A WAS FOUND IN VIOLATION 1 TIME(S).

Floors, walls, ceilings, not smooth, properly constructed, in disrepair, dirty surfaces

Inspector Findings

Observed broken floor tiles in room with 3 bay sink. Interview indicated that floor tiles keep lifting so entire floor needs to be replaced. Still under TTOC of 4/27/17
