## IMPROPER COOLING AND REFRIGERATED STORAGE OF POTENTIALLY HAZARDOUS FOODS.

### ITEM # 5A WAS FOUND IN VIOLATION 1 TIME(S). CRITICAL VIOLATION

All or parts of the violation item are IN violation.

#### Code Requirements

Potentially hazardous foods are not kept at or below 45oF during cold holding, except smoked fish not kept at or below 38oF during cold holding.

#### Inspector Findings

At 8:45, observed 5 containers of cream cheese stored on table with no method for active cold holding. Cream cheese is part of cold holding waiver. Manager stated all cream cheese containers opened at 5:30am when they received them. Cold holding waiver states that facility will mark discard time on container with tape and marker and also document times in logbook. No tape with marked discard times observed and last recorded times for cream cheese documented in logbook were from 8/9/16. Facility not following conditions of cold holding waiver. Manager stated she will talk to overnight staff who receive food items and review waiver with them. Manager discarded cream cheese at 9:30am. CORRECTED

#### Comments

Observed boxes of bagels with napkins and tongs used by customers to prevent barehand contact. Observed single use coffee cups for coffee, single use plates, and single use plastic knives for spreading cream cheese.
