The general election limit applies to special elections as well.

Please remember that these limits are for the entire election cycle. Generally, the Election Cycle is either two or four years. Where the limit exceeds \$5,000, a corporation/LLC/PLLC is still restricted to its limit of \$5,000 in a calendar year. But, it may give during each year of the election up to the lesser of it's or the candidate's limit.

The person contributing, as well as the person receiving it, are responsible to ensure that the limits are not exceeded.

- The contribution limit for family members is an aggregate limit from all the candidate's family members (defined as a child, parent, grandparent, brother and sister and the spouses of those persons.)

Unless otherwise designated in writing, a contribution is deemed attributable to the very next election in which the candidate participates. Contributions allocated to prior campaigns (to pay outstanding debts) must remain within the limits applicable to that election.
